OMMS Band and Choir Spring Trip Information May 1-4, 2024 Universal Studios|Orlando, Florida

VERY IMPORTANT stuff you need to know

- Deadline for enrollment/deposit is Spooky-day! October 31st, 2023 @ midnight.
- While unlikely, the Shelby County Board of Education reserves the right to cancel any out-of-state or overnight trips if deemed necessary.
- Parents are REQUIRED to purchase the additional Travel/Trip insurance with the *cancel* for any reason (CFAR) add-on for their child to attend the trip. Without purchase of insurance (with CFAR coverage) students will not be permitted to attend.
- *Gateway Tours* is our trip company and will be collecting all monies associated with this trip. Do not send money to OMMS.

Items of Note (don't skip this part)

- This trip is <u>NOT</u> required.
- This trip is open to any 7th and 8th grade OMMS Band and Choir student who has a record of positive participation in band/choir class. Students who continually disrupt class or who do not show their best effort will not be allowed to attend. All students who plan to attend will sign a "Academic/Behavior Contract" with the directors and their parents.
- Priority will be given to 8th grade students if we exceed our participation limit.
- All band and choir course fees must be paid before making a deposit on the trip. Check with your director to see if you are paid in full.
- Students stay 4 students per room. Each room has 2 double/queen beds. Choir students will room with choir students; band students room with band students.
- If your child has any major limitations (physical, mental, health), we ask that a parent/guardian attend the trip as well.
- Only paying tour-members may travel with the group. Non-tour members are not permitted to participate with the tour group in any travel, activity, performance, etc. This is for the safety of all participants.
 - Family members that are traveling on separate (not OMMS affiliated) reservations that wish to "hang-out" with their student may do so, but are responsible for all travel expenses, reservations, etc., and will not be included in any "group" activities that are specific to our groups (work-shops, meal reservations, etc).
- Students and chaperones pay the same amount.
- We have opened slots for 115 Band students, 115 Choir students, and 20 chaperones. Once slots are filled, we will move to a "waiting list". Funds won't be collected from those on the "waiting list" unless a slot opens for them on the trip. Slots are based on occupancy and group.

Make-up Work

Each student is responsible for communicating with his/her teachers and making up any work that is missed. Talk with teachers ahead of time, so that the work can be spread out and not crammed in at the last minute. Because this is a field trip, students do not receive 3 days to make up the work. Work is due before we leave or the day we return. This includes iReady time. Students who have a history of not completing their required weekly iready minutes will not be permitted to attend the trip.

Extra Rehearsals (as needed)

Students attending the trip will learn their music BEFORE we go. We will have 2-3 after school rehearsals to make sure we are prepared. Students are required to participate in these rehearsals in order to attend the trip. More information will be shared closer to the trip.

Chaperones

- Chaperones may only be OMMS staff or legal parent/guardian of the students attending.
- Chaperone spots are limited and will be filled based on the following order of criteria
 - Need/requirements of the trip (gender breakdown of students, students requiring extra assistance, etc)
 - Director discretion
 - Order of registration
- Chaperones will be expected to work. Don't sign up if you're looking for an easy vacation.
- All chaperones will be required to complete a background check through Shelby County Schools. This will be at your own expense.
- Chaperones will stay 2 adults per room. We do not have any extra rooms reserved for chaperones to have their own room. <u>If you don't want to share a room, don't sign up to be a chaperone.</u>
- Chaperones must ride the bus to/from the trip destination with the group and remain with the group at all times. Absolutely no exceptions.

Academic, Behavior, and Attendance Requirements

This trip is a privilege and meant to serve as a reward for a job well done. Per OMMS Administration, students with excessive school absences (excused or unexcused) will not be able to attend. This will be determined prior to the final payment due date.

We want to take students who are eager to have a good time, but who also understand certain rules must be followed. Please understand that each student selected to go must have the Administration's approval. A student who commits continuous disciplinary infractions or has a consistent history of failing grades will not be allowed to attend. This will be evaluated on a case-by-case basis.

This trip demands maturity and self-sufficiency. The students are expected to be able to carry their own luggage, wake up on their own, shower, brush teeth, put on deodorant, move quickly to maintain a strict schedule, and act responsibly.

Inappropriate behavior will not be tolerated, and, if excessive, could result in the student being flown home at the parent's expense. Should a student break the law, the student will be turned over to local police, and a parent or guardian must come to Orlando and retrieve the student.

Dress Code

We use a modified dress code for the trip, but always want to represent OMMS and be "Nothing But the Best" with our clothing.

- Students may wear athletic shorts of modest length. If we see your "cheeks", you will be asked to change.
- Closed-toe shoes or shoes with straps around the heel are required in the park. This is a requirement of many rides within Universal Studios.

Students will wear their 23-24 OMMS Band or Choir Shirt on Wednesday, May 1st. Thursday, May 2nd – new trip shirt 1 Friday, May 3rd – new trip shirt 2

Saturday, May 4th - Oak Mountain attire preferred

Trip Itinerary/Details and Cost

- **We are still finalizing details with Universal Studios regarding performance/workshop options. We will update our itinerary once we have that information.
- Our estimated cost is \$850- \$900 per person based on 230 students and 20 chaperones. We will know the exact amount per person once deposits have been paid and an accurate number of travelers has been established.

- Three night hotel accommodations at *Universal's Cabana Bay Beach Resort*
- Charter Bus transportation
- 2-Day/2-Park Park-to-Park admission to Universal Studios and Islands of Adventure

 - \$15 each, total of \$60
- Performance/Workshop Fees (\$38 per person)
- Two Spring Trip T-shirts
- Tour planning and Tour Guide services of Gateway Tours
- Bus Driver hotel accommodations, gratuity, and tolls
- Substitute teacher expenses for directors and medication assistant and any other incurred costs.

Payment Information

Important Points:

- DO NOT pay ahead of schedule. We understand that some prefer to pay everything at once, but in the (unlikely) event that there is a cancellation of the trip, this makes things even more difficult. We request that you follow the payment plan outlined below.
- <u>CHOIR STUDENTS ONLY:</u> If you have sponsorship funds in your choir account, your balance will be adjusted to reflect your amount owed.

<u>Registration Information</u>:

- ALL travelers need to create an account and register for the tour. If you have multiple people attending the tour (student and parent), you only need to create one account.
- Students under the age of 18 (all of our students) cannot create an account on their own, so please make sure that a PARENT creates the account and handles registration.
- Follow the link below and use the tour code OMMS2024TOUR to register
 - The link will be sent out when registration opens
- The first payment is due October 31st, 2023

REQUIRED Insurance - Trip Cancel for Any Reason (CFAR Insurance)

- When registering, you might see on the tour website that CFAR is optional. By federal law, travel agencies cannot require CFAR. Shelby County Schools, though, can require the insurance. We have been advised that everyone traveling on the trip must purchase CFAR coverage or they may not travel.
- The cost of CFAR(based on the trip cost) is \$40.00 per traveler. Details can be viewed upon registration. If a parent is traveling as a chaperone, they must also purchase the cancellation insurance.



My Gateway - Registering

To secure your place on the 2024 Oak Mountain Middle School Performance Tour of Orlando, each passenger must be registered on the "My Gateway" online registration system by **October 31, 2023**.

If you've registered on a past tour with Gateway, you are not able to log into a past account without following the steps below, personal information does not transfer over automatically.

A non-refundable deposit of \$100.00 per passenger is also due by October 31st.

- When you register as a user, you must check both boxes and agree to the terms and conditions to continue.
- > Once you have registered as a user on the system, you will be directed to the Dashboard and can click on the "Register your first passenger" button. You can register for multiple passengers, including yourself, from the Dashboard or the Passengers page.

Note: In passenger profile, options under "Role" are Chaperone, Staff and Student.

- At this point, Students should select "quad occupancy" and Chaperones should select "double occupancy." Staff should select "double occupancy" unless they are requesting a single room.
- Students Select Ensemble choice Band, Choir, or Both
- > Chaperones Select Ensemble you are Chaperoning Band or Choir
- Please complete all the information as accurately as possible.
